Inclusion

Offer Letter and internship Placement, Training Plan, Duty meals according to the shift time, Health Insurance, and Accommodation which is provided by the Hotel. Please note that Embassy Visa Fees and Airfare Costs are not included in the program fees.

REFUND & CANCELLATION POLICY

- **Submission Deadline:** You must submit all required documents within 3 months of enrollment. If you fail to do so, your payment will be forfeited, and your file will be closed.
- **Placement Guarantee:** If no placement is found within 4 months of submitting a complete application kit and placement start deposit, you will receive a refund of all amounts paid, minus the enrollment fee.
- **Cancellation Policy:** If you cancel after a placement is arranged but before a visa decision is made, you will not be eligible for a refund.
- **Visa Refusal:** If your visa application is denied, you will receive a refund of all amounts paid, minus, the Enrollment Fee, and the Documentation Fee. However, to qualify for this refund, you must submit all necessary refund documentation within 3 days of the visa refusal.
- **Fraud and Misrepresentation:** No refund will be issued if you submit fraudulent documents to Hexa Global Placement, or if your visa is denied due to providing false information to the Consulate/Embassy about employment, education, or other matters.
- **No Refunds After Visa Approval:** Once your visa has been approved, refunds are no longer possible.
- **No Refunds After Entering the France:** After you have entered France, no refunds will be issued, regardless of changes in placement, termination of placement, or early departure from the country.

Engagement Requirement You must be engaged in full-time education or employment at the time of placement interviews and during the visa application phase. After completing your education, you should start a relevant job within a month or so. If your visa application is denied due to a lack of engagement, no refund will be issued.
